# AI and the law – a look at what the future holds

In 2022, when struggling to get a basic answer from your Alexa, the prospect of an effective Al seemed very distant. By 2023, the ChatGPT Al made headlines by writing poetry, passing human exams, generating computer code and even helping a Colombian judge in deciding a civil claim. With Google and others launching rival Als, the frequency and range of real-world applications of Al is likely to grow exponentially.

This breakfast briefing draws on the expertise of an industry specialist, Peter Jackson, and 5 Essex Court's team of information law barristers to discuss 'what comes next' as well as the moral, ethical and legal implications of this emerging technology.

- What are the legal controls on automated decision-making, how have they been interpreted by the Courts and are these restrictions likely to survive the AI revolution?
- What legal risks arise if governments and companies use AI to make decisions which can have real-world implications for individuals?
- What can or should be done about this rapidly advancing AI future?
